VENDORS ARE NOT ALLOWED TO SET UP ON ANY CITY STREET OR CITY RIGHT OF WAY LOCATED WITHIN THE CITY LIMITS OF LA GRANGE, KENTUCKY, UNLESS THE ROAD IS CLOSED UNDER AN APPROVED "EVENT CLOSING OF RIGHT OF WAY."

VENDORS UNDER THE AGE OF 18 ARE NOT REQUIRED TO GET A VENDOR PERMIT OR BUSINESS LICENSE.

A GOVERNMENT ISSUED IDENTIFICATION MUST ACCOMPANY THIS APPLICATION ALONG WITH A RECENT BACKGROUND CHECK FOR THE COMMONWEALTH OF KENTUCKY FOR ALL ININERANT MERCHANTS WHO ARE GOING DOOR TO DOOR.
