6. THE PERMIT HOLDER AGREES TO PROMPTLY REPAIR ANY DAMAGE TO THE CITY'S RIGHT – OF – WAY RESULTING FROM HIS/ HER ACTIONS OR THOSE OF HIS AGENTS TO INCLUDE ROADWAY, DITCHES, SHOULDERS, ETC., DURING THE PERMITTED CONSTRUCTION.

7. THE PERMIT HOLDER AGREES TO KEEP ALL TRACKED EQUIPMENT OFF ASPHALT AND CURBS DURING CONSTRUCTION.

8. AT ANY TIME DURING THE CONSTRUCTION ON SAID PROPERTY, FAILURE TO COMPLY WITH THE TERMS OF THIS PERMIT SHALL RESULT IN A STOP WORK ORDER TO INCLUDE ANY CONSTRUCTION ON SAID PROPERTY.
