**CALL MEETING TO ORDER** Mayor Black calls meeting to order at 6:30 p.m.

**APPROVAL OF JULY 2021 AGENDA** Councilman Taylor recommends that Mr. Fromeyer with AmLegal to be moved up agenda. Councilwoman Wright made motion to approve July 2021 agenda, second by Councilwoman Pollard. The motion in favor of passed unanimously, 8 to 0.

## RESOLUTION 11-2021 - RESOLUTION OF THE CITY OF LAGRANGE APPROVING AN IMPROVEMENT PROJECT BY THE UTILITY COMMISSION AND AUTHORIZING THE UTILITY COMMISSION TO FINANCE THE IMPROVEMENT PROJECT.

After presentation by Scot Treece concerning the project, Councilwoman Wright made motion to approve Resolution 11-2021, second by Councilwoman Carter. The motion in favor of passed unanimously, 8 to 0.

It was noted that Department of Local Government has two or three million dollars that has been made up recently from Affordable Cares Act funds for utility districts around state. Oldham is part of an area made up of Oldham, Shelby and Trimble Counties. The money is a grant to assist customers with past due water, sewer, utilities bills up to a total amount of \$200,000. The agency that is going to be funneling this money back to the customers once it gets going will be Tri-County Community Agency.

## **BID EVALUATION SUMMARY FOR LAGRANGE SPRINGS PARK**

Springs Park Committee Chair Ann Zimlich distributed brochures and explained current plans for Phase 1 of the Springs Park, which include a farmers' market pavilion, playground, splash pad and large parking area. The design team of Sarah Jones and Jodi Smiley summarized the four bids received by the City on June 28, 2021 (Calhoun Construction, Churchill McGee, EZ Construction, MAC Construction) and explained the competitive bidding and evaluation process used by the voting members of the evaluation committee (Mayor Black, Joe Davenport, Bill Lammlein, Jodi Smiley and Ann Zimlich) after thoroughly discussing all the prices and qualifications submitted by the bidders. Details of the bid tabulation and bid evaluation summary printouts were discussed explaining the bid price for scoring was the sum of the base price and the accepted alternates 1-3, 5-7. Scoring was also based on the qualifications, experiences and references of bidders and their subcontractors, along with pictures and information submitted by each bidder. After thoroughly discussing the pricing and qualifications, the bid evaluation committee recommends Calhoun Construction with the most points being both price and qualifications, for a total price of \$4,527,074. Motion was made by Councilman Lammlein to approve Calhoun Construction as the major contractor, seconded by Councilwoman Wright, and roll call vote was taken: Lammlein-yes, Taylor-no, Davenport-yes, Wright-yes, Carter-no, Essenpreis-yes, Pollard-yes, and Kamer-yes. The motion passed with 6-yes and 2-no.

<u>JIM SILLIMAN, COUNTY ENGINEER, AMENDMENT #1 TO EAST PEAK ROAD</u>
<u>CONSTRUCTION CONTRACT</u> Jim Silliman discussed the amendment #1 on East Peak Road. Councilwoman Carter made motion, second by Councilwoman Essenpreiss. The motion in favor of passed unanimously.

**AMERICAN LEGAL PUBLISHING** Councilman Taylor discussed about the legal review of ordinances. Richard Frommeyer from American Legal explained to City Council about having the legal review done. Councilwoman Wright made motion to approve the contract with American Legal for the recodification proposal that was presented, second by Councilwoman Pollard. The motion in favor of passed unanimously, 8 to 0.
