**AN ORDINANCE AMENDING §32.21, PART (A) CONCERNING
"MEETINGS" TO INCLUDE MEETING LOCATION AND TIMES FOR
COMMITTEES AND BOARDS**

WHEREAS, the Mayor and City Council of the City of La Grange, Kentucky, have the authority pursuant to statute to enact Ordinances relating to the City, and

WHEREAS, the Mayor and City Council deem it necessary to establish the location and times of the committees, boards and historic district commission meetings of the City;

THEREFORE, IT IS HEREBY ENACTED AND ORDAINED BY THE CITY OF LA GRANGE THAT,

(A) The regular City Council meeting shall be conducted on the first Monday night of each month unless a holiday shall fall on a regular meeting night, at which time the meeting shall be held on the next regular weekday which is not a holiday. The meeting shall begin at 6:30 p.m. in the Oldham Fiscal Courtroom, Oldham County Fiscal Court Building, Jefferson Street, La Grange, Kentucky.

The regular budget committee meeting shall be conducted on the second Monday night of each month, unless a holiday shall fall on a regular meeting night, at which time the meeting shall be held on the next regular weekday which is not a holiday. The meeting shall begin at 6:30 p.m. in City Hall.

The regular ordinance committee meeting shall be conducted on the third Monday night of each month, unless a holiday shall fall on a regular meeting night, at which time the meeting shall be held on the next regular weekday which is not a holiday. The meeting shall begin at 6:30 p.m. in City Hall.

The regular city bus committee meeting shall be conducted on the fourth Monday night of each month, unless a holiday shall fall on a regular meeting night, at which time the meeting shall be held on the next regular weekday which is not a holiday. The meeting shall begin at 6:30 p.m. in City Hall.

The regular insurance committee meeting shall be conducted on the fourth Tuesday night of each month, unless a holiday shall fall on a regular meeting

night, at which time the meeting shall be held on the next regular weekday which is not a holiday. The meeting shall begin at 6:30 p.m. in City Hall.

The regular park board meeting shall be conducted on the first Wednesday night of each month, unless a holiday shall fall on a regular meeting night, at which time the meeting shall be held on the next regular weekday which is not a holiday. The meeting shall begin at 6:00 p.m. in City Hall.

This Ordinance shall become effective upon its passage and publication.
