CITY OF LA GRANGE, KENTUCKY

**MODIFYING § 98.05 CONCERNING FISHING**

**Whereas**, the City Council of the City of La Grange, Kentucky, has the authority pursuant to statute to enact Ordinances relating to the City, and

**Whereas**, it is desirable that specific terms concerning fishing be added to the existing ordinance.

**THEREFORE, BE IT ENACTED AND ORDAINED THAT § 98.05 OF THE CODE OF ORDINANCES BE MODIFIED AS FOLLOWS:**

**§ 98.05 FISHING POLICY AT WILBORN PARK, THE GLEN, AND EAGLE CREEK GOLF COURSE.**

~~(A) "Catch and Release" with designated times for "Catch and Keep."~~

- ~~—(1) Opening weekend.~~
- ~~—(2) Memorial Day.~~
- ~~—(3) Independence Day (July 4th).~~
- ~~—(4) Oldham County Day.~~
- ~~—(5) Labor Day.~~

~~(B) Catch and Keep Rules:~~

- ~~(1) One (1) pole per fisherman.~~

(2) Rainbow Trout:

a) Daily Limit: 5

b) Minimum Size Limit: None

c) No culling of trout (culling is holding a trout in a live well, fish basket or stringer and later replacing it with another)

(3) Largemouth Bass:

a) Daily Limit: 1

b) Minimum Size Limit: 15"

(4) Catfish:

a. Daily Limit: 4

b. Minimum Size Limit: None

(5) Bluegill/Other Sunfish:

a. Daily Limit: 15

b. Minimum Size Limit: None

(6) Fifteen (15) fish limit per 24-hour period

(B) Fishing is permitted at Wilborn Park, The Glen, and at Eagle Creek Golf Course; however, at the golf course, fishing is only allowed at the front pond adjacent to Highway 53 and the side pond at the golf course adjacent to Lakewood Drive. Fishing is prohibited at all other ponds at the golf course.
